
Introduction of Bokaro Delivery Point and 12 Monthly Contracts

Dear Members,

In pursuance to Byelaws and Market Rules of IGX, Members are notified as below –

1. Bokaro Delivery Point – In accordance with PNGRB approval vide letter dated 11.05.2022, Members may kindly note that Bokaro Delivery Point in Eastern Regional Hub will be made active for trading from trade date 08.04.2024 onwards. Details of contracts available for trading at Bokaro Delivery Point is mentioned below-
 1. Contract Code:
 - a. Name of the Delivery Point : BOKARO (BK)
 - b. Contract Name:
 - i. Day-Ahead : DA-BK-dd/mm/yy - DAY
 - ii. Daily : DL-BK- dd/mm/yy - DAY
 - iii. Weekday : WD-BK- dd/mm/yy - dd/mm/yy²
 - iv. Weekly : WK-BK- dd/mm/yy - dd/mm/yy²
 - v. Fortnightly : FN-BK- dd/mm/yy - dd/mm/yy²
 - vi. Monthly : MN-BK-dd/mm/yy-MMM-YYYY
 2. Price Matching Mechanism: In reference to Master Circular ver. 3, Circular No. IGX/MO/96/2023, trade at Bokaro Delivery point will be happening under Free Market gas category with price discovery mechanism as mentioned below:
 - a. For Weekday, Weekly, Fortnightly and Monthly Contracts: Double sided Open Auction and Price-Time Priority basis.
 - b. For Day-Ahead and Daily Contracts: Continuous Trading basis.
2. Additional Monthly Contracts - Six additional Monthly Contracts will be introduced along with existing Monthly Contracts at all Delivery points from trade date 08.04.2024 onwards.

Rest all details for Monthly Contracts will remain same as mentioned in IGX Master Circular (ver.3) and Contract Specifications (Annexure-A) of the Market Rules.



The Trading Calendar for Monthly contracts is attached under Annexure-I.

Members are requested to kindly make a note of all the above changes and act accordingly. This Circular will come into effect from Trading date April 08, 2024, till further notice.
