Introduction of Mallavaram Delivery Point

Dear Members,

In pursuance of the Byelaws and Market Rules of IGX, Members may kindly note that IGX will be introducing new contracts for trading at Mallavaram Delivery Point from trade date 02.08.2024 onwards. The details of new contracts available for trading at Mallavaram Delivery Point are mentioned below

1. Contract Code:
 - a. Name of the Delivery Point : Mallavaram (Ceiling Price)
 - b. Contract Name:
 - i. Day-Ahead : DA-ML-dd/mm/yy – DAY -CP
 - ii. Daily : DL-ML- dd/mm/yy – DAY-CP
 - iii. Weekday : WD-ML- dd/mm/yy - dd/mm/yy-CP
 - iv. Weekly : WK-ML- dd/mm/yy - dd/mm/yy-CP
 - v. Fortnightly : FN-ML- dd/mm/yy - dd/mm/yy-CP
 - vi. Monthly : MN-ML-dd/mm/yy-MMM-YYYY-CP
2. Price Matching Mechanism: In reference to Master Circular ver. 3, Circular No. IGX/MO/96/2023, the trade at Mallavaram Delivery point will be happening:
Double sided Open Auction and Price-Prorata-Time Priority basis, for all Contracts viz., Day-Ahead, Daily, Weekday, Weekly, Fortnightly and Monthly

Other trading, clearing and settlement details will remain the same as mentioned under the Ceiling Price gas contract in Master Circular No. IGX/MO/96/2023 and Contract Specifications (Annexure-A) of the Market Rules.

Also, Ceiling Price Contracts symbol 'CP' will be added as suffix against each contract symbol.
