Mock Trading Session for 3 Month & 6 Month Market Segment

Dear Members,

In pursuance to Bye-Laws and Market Rules of the Exchange, we are pleased to inform that IGX will be launching Term Ahead Contracts for 3 Month and 6 Month delivery period from 3rd February 2025. Accordingly, Members are hereby notified as under –

1. IGX will be conducting a Mock trading session on Thursday, 30th January 2025 from 03:30 pm to 04:30 pm, with market extension till 05:00 pm, in order to acclimatize Members on the trading of 3 Month and 6 Month contracts on TradeHub.
2. For Mock trading on 30th January 2025, following contracts will be made available –

Product	Contract Code	Contract Underlying
3Month	3M-<Index>-<BidPara>-<DelP>-<MMM1/MMM2>*	Four consecutive 3Month (3M) separate contracts for 3 Month delivery with price linkage to GIXI, JKM, WIM and BRENT
6Month	6M-<Index>-<BidPara>-<DelP>-<MMM1/MMM2>	One 6Month (6M) contracts for next 6 Month delivery with price linkage to GIXI, JKM, WIM and BRENT

*Index = Price Linkage (GIXI, JKM, WIM and Brent), BidPara = P (Constant) or S (Slope),
Delp – Delivery Point, MMM1 = Delivery start , MMM2 = Delivery end

3. Members are hereby informed that any trades executed during the mock trading session will not create any delivery commitments or financial obligations. Details of Mock trading environment are as below -
