Dear Members,

In pursuance to the Byelaws and Market Rules of IGX, Members may kindly note that trading will be available from 16.06.2025 onwards at the following 3 delivery locations for the existing delivery points KG Basin and Hazira: -

Name of Delivery Point/Location	Code	Location
Hazira - ONGC	HO	Tie-in point on the GAIL's p/l at ONGC's Gas Processing Terminal at Hazira in Gujarat (GTP-01, Hazira)
KG - Mandapeta	KM	Tie-in point on the GAIL's KG basin Natural Gas p/l at Mandapeta in Andhra Pradesh
KG - Pasarlapudi	KP	Tie-in point in the GAIL's KG basin Natural Gas p/l at Pasarlapudi in Andhra Pradesh

- Intraday – ID-DP-dd/mm/yy - DAY
- Day-Ahead - DP-MT-dd/mm/yy - DAY
- Daily - DL-DP- dd/mm/yy - DAY
- Weekday - WD-DP- dd/mm/yy - dd/mm/yy²
- Weekly - WK-DP- dd/mm/yy - dd/mm/yy²
- Fortnightly - FN-DP- dd/mm/yy - dd/mm/yy²
- Monthly - MN-DP-dd/mm/yy-MMM-YYYY

- 2. Price Matching Mechanism:** In reference to Master Circular ver. 3, Circular No. IGX/MO/96/2023, the trade at these delivery points will be happening under Free Market gas category with price discovery mechanism as mentioned below:



- a. For Weekday, Weekly, Fortnightly and Monthly Contracts: Double sided Open Auction and Price-Time Priority basis.
- b. For Intraday, Day-Ahead and Daily Contracts: Continuous Trading basis.

Other trading, clearing and settlement details will remain same as mentioned under Free Market Gas category in Master Circular No. IGX/MO/96/2023 and Circular no : IGX/MO/155/2024, and Contract Specifications (Annexure-A) of the Market Rules.

Members are requested to kindly make a note of all the above changes and act accordingly.

This Circular will come into effect from the Trading date Jun 16, 2025, till further notice.
