Introduction of Tatipaka Delivery Point

Dear Members,

In pursuance to the Byelaws and Market Rules of IGX, Members may kindly note that in addition to existing contracts, KG - Tatipaka delivery point in KG Basin under Free Market Gas category will be made available for trading from 03.11.2025 onwards.

1. Contract Code:

- a. Name of the Delivery Point – KG - Tatipaka (KT)
- b. Location - Tie-in point on the GAIL's KG basin Natural Gas p/l at Tatipaka in AP
- c. Gas Category – Free Market Gas
- d. Contract Name:
 - i. Intraday – ID-KT-dd/mm/yy - DAY
 - ii. Day-Ahead - DA-KT-dd/mm/yy - DAY
 - iii. Daily - DL-KT- dd/mm/yy - DAY
 - iv. Weekday - WD-KT- dd/mm/yy - dd/mm/yy²
 - v. Weekly - WK-KT- dd/mm/yy - dd/mm/yy²
 - vi. Fortnightly - FN-KT- dd/mm/yy - dd/mm/yy²
 - vii. Monthly - MN-KT-dd/mm/yy-MMM-YYYY
 - viii. Balance of Month - BM-KT-dd/mm/yy-MMM-YYYY

2. Price Matching Mechanism: In reference to Master Circular ver. 3, Circular No. IGX/MO/96/2023, the trade at these delivery points will be happening under Free Market gas category with price discovery mechanism as mentioned below:

- a. For Weekday, Weekly, Fortnightly, Monthly and Balance of Month Contracts: Double sided Open Auction and Price-Time Priority basis.
- b. For Intraday, Day-Ahead and Daily Contracts: Continuous Trading basis.

In addition to the above, following two changes have been implemented in TWS and will be effective from **03.11.2025** onwards:

1. The status “**Partially Filled/Filled**” will now be displayed as “**Traded**”.
2. The contract names **JKM**, **WIM**, and **Brent** in **LDC** have been renamed to **Platts JKM**, **Platts WIM**, and **Platts Brent**, respectively.

Members are requested to kindly make a note of all the above changes and act accordingly.
