
Introduction of Palanpur Delivery Point

Dear Members,

In pursuance to Byelaws and Market Rules of IGX, Members may kindly note that in Natural Gas segment, Palanpur delivery point under Free Market Gas category will be made available for trading from June 16, 2026, onwards. Details as below:

1. Contract Code:

- a. Name of the Delivery Point – Palanpur (PL)
- b. Location – Palanpur (Interconnection of GTL-GIGL pipeline)
- c. Contract Name:
 - i. Intraday: ID-PL-dd/mm/yy - DAY
 - ii. Day-Ahead: DA-PL-dd/mm/yy - DAY
 - iii. Daily: DL-PL- dd/mm/yy - DAY
 - iv. Weekday: WD-PL- dd/mm/yy - dd/mm/yy
 - v. Weekly: WK-PL- dd/mm/yy - dd/mm/yy
 - vi. Fortnightly: FN-PL- dd/mm/yy - dd/mm/yy
 - vii. Monthly: MN-PL-dd/mm/yy-MMM-YYYY
 - viii. Balance of Month: BM-PL-dd/mm/yy-MMM-YYYY
 - ix. Balance of Month (Power): BP-PL-dd/mm/yy-MMM-YYYY
 - x. Monthly Power: MP-PL-dd/mm/yy-MMM-YYYY
 - xi. Fortnightly Power: FP-PL- dd/mm/yy - dd/mm/yy
 - xii. Weekly Power: WP-PL- dd/mm/yy - dd/mm/yy
 - xiii. Monthly Flexible: MF-PL-dd/mm/yy-MMM-YYYY
 - xiv. Fortnightly Flexible: FF-PL- dd/mm/yy - dd/mm/yy
 - xv. Three Month: 3M-<Index>-<BidPara>-<DelP>-<MMM¹/MMM²>
 - xvi. Six Month: 6M-<Index>-<BidPara>-<DelP>-<MMM¹/MMM²>



2. **Price Matching Mechanism:** In reference to Master Circular ver. 3, Circular No. IGX/MO/96/2023, the trade at these delivery points will be happening under Free Market gas category with price discovery mechanism as mentioned below:
- a. For Intraday, Day-Ahead and Daily Contracts: Continuous Trading basis.
 - b. For other Contracts: Double-sided Open Auction and Price-Time Priority basis.

Other trading, clearing and settlement details will remain same as mentioned under Free Market Gas category in Master Circular No. IGX/MO/96/2023 and Circular No. IGX/MO/155/2024, and Contract Specifications (Annexure-A) of the Market Rules.

Members are requested to kindly make notes of all above changes and act accordingly. This Circular will come into effect from Trading date June 16, 2026, till further notice.
